

## Brooklyn Bridge Sail Club, LLC Instructor Affiliate Agreement

I, \_\_\_\_\_\_\_ (print name), understand that being an Instructor Affiliate ("IA") at the Brooklyn Bridge Sail Club, LLC ("BBSC") entails a high level of responsibility as my actions, inactions and omissions can affect the wellbeing of students, fellow IAs, coaches, the Club and the enjoyment of all Club Members, both current and future. By becoming an Instructor Affiliate at the Club. I agree to the following:

- To be familiar with and abide by all Coaching and Club Rules, Policies and Protocols ("Rules") for the conduct of Coaches, Club Members, Club Skippers and the use of Club Boats. I understand that these Rules are posted on the Club website and that it is my responsibility to keep informed of changes or updates to these Rules.
- 2. To share my sailing knowledge for the betterment of students, fellow IA, coaches, BBSC, its members and the boating community
- 3. To make reservations for a minimum of eight Fleet Captain sailing sessions per month. It is understood that not all reservations for Fleet Captain sailing sessions will be honored, but regardless, they will be counted towards the minimum reservation requirement.
- 4. To follow lesson plans and teach/coach in the manner prescribed by BBSC, and other duties as required by the Director of Sailing Operations
- 5. To acknowledge that BBSC has developed teaching materials, procedures and processes which have considerable intellectual property value and are considered proprietary. I agree that I will make my best efforts to keep this information proprietary and to agree not disseminate, share or use this information in a manner that could be detrimental to BBSC unless authorized by the Director of Sailing Operations.
- 6. To acknowledge that information relating to BBSC, its students and Club Members is valuable property and contains confidential information and that this information shall not be used for personal or commercial use unless authorized by the Director of Sailing Operations.
- 7. BBSC's use of photos and names. IAs irrevocably consent to the use of their names, biographies and their images (digital or otherwise) by the Club and its affiliates taken while participating in Club or Club-related activities, in any form or media, but not limited to social media, electronic mail, marketing, promotional and advertising materials.
- 8. That this position is a volunteer position and no compensation or employment benefits are being offered
- 9. That any conflicts between the IA, Coaching and Club Rules must be brought to the attention of the Director of Sailing Operations
- 10. That there are no warranties or assurances provided as to the length or type of IA assignments and this agreement can be terminated at will by BBSC or the undersigned at any time.
